Overview

Even as Thailand’s digital transformation speeds up, cybercriminals are keeping pace. In 2024 alone, [Group-IB Threat Intelligence](#) recorded over 60 attacks on government agencies and 40 attacks on financial services, which shows that these sectors should be top priorities for cybersecurity initiatives in the country.

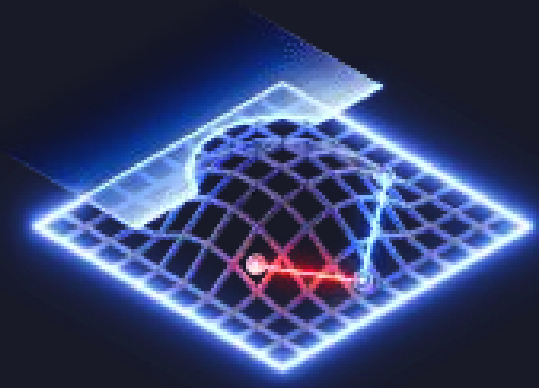

Attack Surface Management



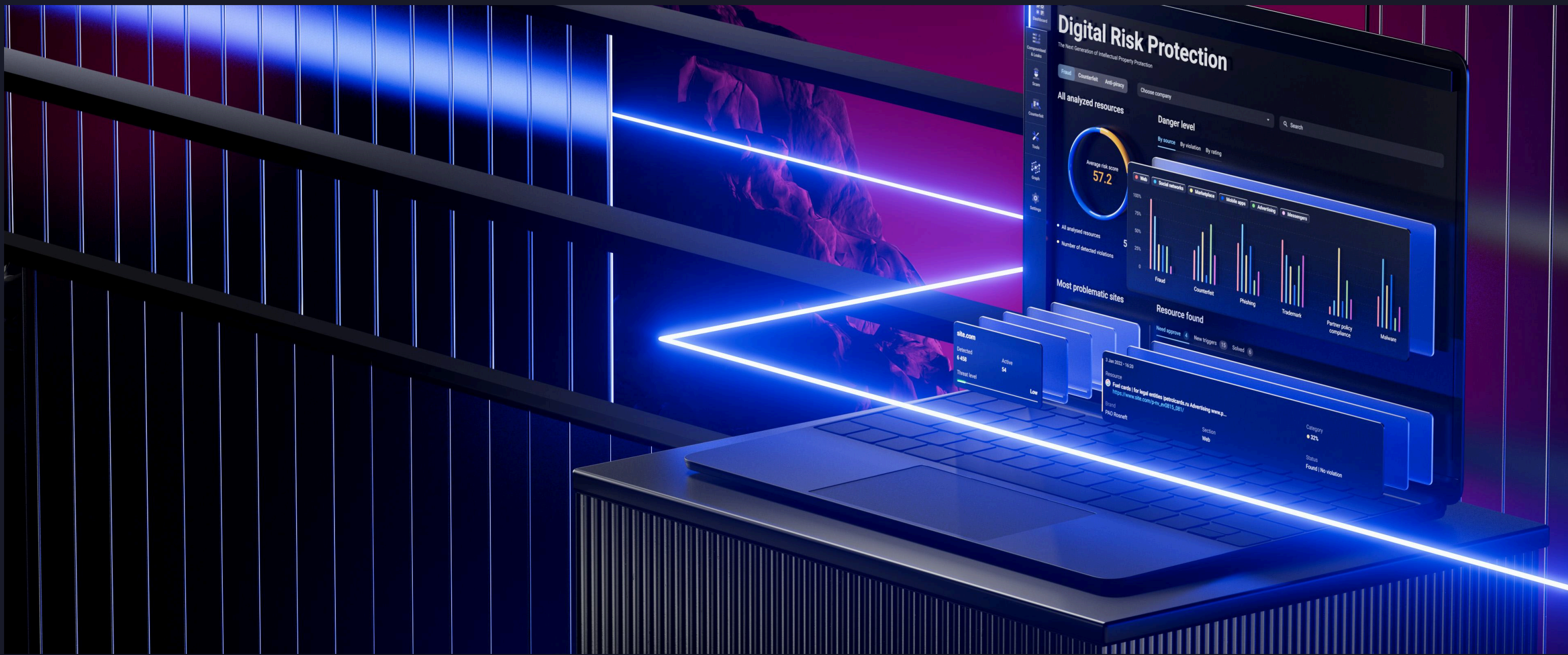
